

## There are two of you

I have noticed from the reactions I get to my work that people have a hard time grasping the concepts of how the legal system is deceiving them.

These two of you are **not** the same. People are confused by the knowledge I put out, because they **believe** that they **are** the document. That is why they cannot comprehend the content, because all their lives they have been **told** that they are the document. And they accepted that to be able to function in society. When you accept something you rarely then think about it anymore. You just move on with your life.

It is so accepted, so vehemently pushed and so strongly promoted that almost nobody ever questions it.
