## Your next move: Refuse the Digital ID at all cost.

If you are new to this subject, I recommend you to watch this **presentation** as it lays out in general terms what is planned for you for the future. In a nutshell it is this: The future of all human interaction will be digitized and it **all** starts with the digital identification, the Digital ID. It is just a digital form of your passport or birth certificate. It is a **digital form** of the **legal fiction**. It is not real, but it exists in the digital world, i.e. somewhere on servers linked to the internet. And they want you to **act on its behalf**. In everything you do, you will act as if you **are** the digital ID. And when you scan your face in any interaction with the system, you will acts on its behalf. You will put on a mask and claim that you are the digital ID.

But because it is digital, everything that is private to you will also be **linked** to that digital ID: health records, commerce, financial transactions, governmental documents, travel, internet access, telecom and all your belongings.

For everything you want to do in society you will need to identify with your digital ID. That will happen by scanning your face for everything: from buying things, to accessing websites on the net, traveling or making a phone call.

This is because everything you want to do when you interact with the system is a **contract**. It is an agreement between **you**, requiring a **service** from the system and the **system** providing that service to you. Since the agreement is a **contract** there are **terms** to observe. How it usually goes, is that you will have to **obey** the requirements of the system to get the benefits of the agreement. And since you **want something** from the system, the system **wants something** from you. The something that the system wants from you is **compliance**.

The problem is that the system will be organized around a digital ID, a social credit score and Central Bank Digital Currencies (CBDC's). This means in a nutshell that the more 'obedient' you are, the higher the social credit score and thus the more 'privileges' you will have, whereas the less 'obedient' you are the less things you are allowed to do. Also the CBDC's are programmable, which means any (central) bank will decide what you can buy or not buy, how fast you should spend those credits and where exactly you can spend them. In other words, your wallet will be controlled by somebody else.

**Unless**, you **refuse** the digital ID. This whole circus starts and ends with the digital ID. The digital ID is the holy grail of your enslavement. It works the same as in the legal system with your ID card, as I explained in **my book**.

If you don't want that level of intrusion in your life, you can stop the whole circus in its tracks. **Without** you **consenting** to the digital bamboozlement, it cannot operate. If you

**refuse the digital ID**, there is no agreement and thus no contract. When there is no contract, there is nothing to 'comply' with. The digital ID is **not** here yet. And there will be a day that they will make you an **offer**. Either through a marketing pitch or scare, or through world wide media hoaxes or just a financial pay-off.

You would say that this means you will have no access to any of the services that the system provides, and that is correct. What the system controls is inaccessible. But you can start thinking of building your life outside of the system. Off-grid. An alternative system without all the exploitation. Without the bamboozlement. Every geographical region has different options and challenges, so you have to gauge for yourself what would work in your area. It would probably help to team up with others. Set aside the disagreements and see where **one core value** can help to form a cohesion to live with dignity. This core value can be being free of an extremely oppressive system.

Sure you can say "let's just take the digital ID and see". Sure, you can get the free money bribe the government is going to offer. Sure, you can believe the BS from the media when the internet is going to be hit with a massive 'cyber attack' which will launch everything into 'Zero trust' and blame it on the 'Russians' or the 'North Koreans' or the 'Iranians'. Sure all of that is possible. But you know that you are going to be fleeced one way or the other. Don't fall for it. It is the **usual suspects**, creating a problem to **scare** you to **accept** the digital ID.

But once you are **in**, it is going to be very difficult to get out. If you **agree** to the **digital ID** you will be locked in. Your face will be locked in. You will have a **contract with them**. And when you have a contract with them, you will have to **obey**. Once you are in, they are going to **turn the thumbscrews** step by step. With every step, there will be more requirements and more rules and more hoops you have to jump through, until one moment will come when they will hit your limit. And then it will be extremely difficult to get out.

There will be pain initially to refuse the digital ID, but that pain will be far less than when you will realize down the line that they did a number on you and that the social credit score – CBDC - digital ID system - is not pleasant at all. You realize that it will be a living hell.
