

## **Chaos in Ecuador is 100% staged.**

I was sent this story by a friend and decided to look into it. It is a weird story, but with easy to spot incongruencies and things that make no sense. As usual, when I smell a rat, then there usually is a dead rat somewhere. And there is. Let's have a quick look. I have updated this paper twice. The updates are at the end.

Just fresh into the new year, a few things unfolded in the country of Ecuador that are obvious hoaxes. I will list them here briefly and conclude at the end where all this is heading. As usual, I am pulling up some main stream articles to show you how ridiculous this story is and how obvious the plan of the controllers is.

1. A few days into office, the new president of Ecuador, Daniel Noboa, made his new plans public on which he wants to focus during his presidency. One of the most notable points was the security situation<sup>1</sup> in his country. The fight against 'organized crime'. This is where we get on slippery ice. Anytime you hear 'fight against organized crime' or 'war on drugs', be cautious as you are about to get fleeced.

Noboa call his plan 'Fenix' or 'Phoenix'. 100% red flag. The phoenix is the major symbol of international Freemasonry and also for the Jewish international banking dynasties. It is a codeword for the fact that the Phoenix bird will rise from the ashes of chaos. In other words, the controllers will inflict chaos on a nation to establish change. The bird with the new coat of feathers will rise from the ashes of the old. It is all about transformation towards something new. And that is exactly what is happening now in Ecuador. Noboa's plan is basically to instigate fear on the population of Ecuador in order that it will accept radical changes that are not constitutional. This new plan aims at giving police and military more liberties to use force against 'organized crime', gangs and 'terrorists'. Once you have that label, the army can swoop you up and deal with you. It is unconstitutional<sup>2</sup> and that is why Noboa will organize a referendum in **February** of this year to persuade people to vote yes for more powers for the army and national police to control the population.

The excuse is of course 'combating narco-gangs', but that is the usual bullshit, because the gangs are already controlled through the most powerful Ecuadorian industrial families that are either Jewish or have links with the international Jewish banking families. The modus operandi of controlling these gangs is through the intelligence factions of both the National police and the army. The

powerful Ecuadorian families are the ones that enable the drug trade by using Ecuador as a main traffic hub for cocaine from Bolivia, Peru and Colombia. The families profit enormously from this drug business. The narco-gangs are just the excuse they use to inflict chaos to come about change that they want.

2. Just a few days ago the 'most dangerous' gang leader, José Adolfo Macías, alias Fito, connected with the drug trade, went missing from prison<sup>3</sup>. The previous day he was in his cell and the next morning he was gone. You have to laugh. The usual bullshit story. How can the most dangerous criminal actual be missing? Watch the wording: he did not escape, but he is 'missing'. The major gang leaders in the world are intelligence agents, running projects for life until they get a faked death. Many famous ones were intelligence agents. So is this guy. He runs the drug trade for the families and if things go sideways, it is all on him and not on the families.

So what happened? Two options: He was relocated to a different place until the right moment comes when the government will 'catch him' and show him off to the media or he is still in 'prison', but shielded from the cameras for the exact same media moment to prop him at the right time.

3. Following this 'missing' story, riots erupted in prisons and president Noboa declared a 60 day state of emergency<sup>4</sup> as an answer to these riots. You have to be kidding me. Who believes this nonsense? First of all, you don't declare a state of emergency after prison riots and secondly how are those riots even possible? I am telling you: **they aren't**. The riots are **allowed to happen**. In any normal prison system, inmates have no chance to organize, let alone riot etc. In a normal prison system, the guards control everything and no inmate has **any chance** to inflict chaos there. **Zero chance**. So the situation in Ecuador is allowed to happen. This means that the government is **creating the problem itself**. We will get into why it wants chaos in a moment. This state of emergency gives the president the power to deploy troops on the street and to give national police exceptional powers, which basically entails the use of unprecedented lethal force against **anybody** it deems as a threat. Not only narco gangs, but **anybody**. Do you see the problem here?
4. But the hoax is getting better. After the declaration of the state of emergency, even more riots broke out in almost all prisons and on top of that **inmates** managed to take over and to hold more that one hundred guards hostage all over the country. How about that? Ecuador's prison system must be organized just like in La La land. In La La land, the inmates have the guns and can manage to take control of the prison. Isn't that wonderful? You get my point, I reckon. This is **impossible** in any other prison system. Inmates do not have guns, but the guards do. And there is zero chance that the inmate can organize, break out and take weapons to take the guards hostage. It is **fake**. It is not real. And if this actually happened, it was **allowed** to happen.
5. But this hoax is not done yet. The second most dangerous leader **escaped**<sup>5</sup> from prison on the first day of the national state of emergency. Wow, and they **really**

expect us to believe this? So two criminal leaders are missing in as many days. You have to be asleep to believe this. Both criminal leaders are intelligence agents. They lead the 'gangs' to instigate chaos in Ecuador on behalf of the powerful Ecuadorian industrial families that control the government. They are just paid actors and they answer to these families and their intelligence groups. It is all set-up. Just like the 'war on drugs' and the 'war against the criminal gangs'. It's all bullshit and window dressing. Drug business is insanely profitable, so you think these international Jewish families want that to go away?

6. But it gets even better. Noboa elevated the national emergency after 'criminals' entered a TV studio to take the presenters and guests hostage<sup>6</sup> and to threaten them on live TV. This is all cute and all, but there is one problem: The TV studio attack is **fake**. You can see the 'criminals' wearing microphones:



They were also flashing 'home-made' grenades and pistols. It looks 100% fake. The most ridiculous thing about this whole TV studio hoax was that after a while the 'criminals' left the studio, got out the building from the front door and lay down on the floor in front of the studio where police and army apprehended them.

These must be the most stupid criminals in the history of crime. It is quite obvious this was another mini hoax to give the president a reason to go full fledged fascistic on the population and completely ignore the constitution. Noboa ordered<sup>7</sup> a lock down between the hours of 11 pm and 5 am. Reminds us of the covid hoax, doesn't it?

7. In many cities local people went nuts of fear: closed shops, people stampeding home and being frantic. The government did its job well.

The situation at the moment is that the two major gang leaders are still 'missing' and that the government has 'regained' control<sup>8</sup> over the prisons. But the people in Ecuador still have to sit out the nonsensical 60 day lock down and people are still scared shitless of the 'narco-gangs'.

So you might ask: **why**?

It's very simple. To instigate **chaos** and **fear** to remind people to vote **yes** for the upcoming referendum<sup>9</sup> in February.

Fear, fear, fear!

Fear is a great motivator to direct the cattle into the direction you want. What you see and read about now is all manufactured. None of it is genuine. They are creating a problem in order that the people will react to the government to do something about this. The solution is very clear. The upcoming referendum is a first step to a total political change for Ecuador. The other reason to pull this hoax is to give the government, national police and army unprecedented powers and control over the population. No need to look at the constitution anymore, but go with full force to do anything you like.

As predicted, the government has released nine more additional 'questions' for the referendum in February. It now really shows its true colors as the questions clearly show that the government is eroding much of the rights that people have. You can read the additional ones here<sup>10</sup>. As I said before, these questions are designed to circumvent the constitution and give the state, national police and army unprecedented powers that they **should not have**. Two questions state to just change the constitution all together. One question aims to give the government the power to seize all assets of 'criminals'. This fraud keeps on giving.

A few days ago American-born Noboa did an interview<sup>11</sup> with fake news channel CNN. He said he needs help in the form of equipment, weapons and **intelligence** to fight the fake war against drugs and the so-called 'narco-terrorists'. He wants to militarize the ports and borders and apply surveillance technology.

What does this mean? That Ecuador will become one giant prison. And with 'intelligence' he means allowing the CIA to operate freely in Ecuador.

It is constitutionally not allowed to have foreign military bases within Ecuador, but with the presence of the FBI, US military and the CIA in Ecuador, that is de facto what is happening. Noboa just doesn't call it that way: he calls it 'help'.

United States Southern Command Chief Richardson<sup>12</sup> will oversee all of this and a delegation<sup>13</sup> is already in Ecuador to coordinate this 'help'. Noboa is blatantly by-passing the constitution and is behaving like a dictator already. But it is logical. He has to do it. It is all part of the IMF loan that Ecuador got and those loans come with conditions. Very nasty conditions for the population.

But there is more bullshit coming out of Ecuador:

1. Allegedly the biggest cocaine bust<sup>14</sup> happened for which 22 tons of cocaine was caught by the government. Spoiler alert. It didn't happen. Why? Because the top international Jewish banking families who are connected to the top industrial families in Ecuador **run** the **global drug trade** in close cooperation with the CIA. They would **never** allow 1.3 billion worth of drugs to be confiscated and destroyed. The CIA is the biggest drug dealer in the world and with its presence now in Ecuador you can be sure that those 22 tons of cocaine were shipped already off with different vessels. What you see in the pictures is just propaganda for the masses. There is no cocaine in those bags. You would also know that this is a hoax, because the government has said<sup>15</sup> that it would **mix** the caught cocaine with 'cement, glass, sand, chemicals and water' and sell it as construction materials. Right. They must think we are idiots to believe this. In what reality do people live who believe this crap?
2. Ecuador has allegedly deported 'El Gringo', the so called 'most wanted man in Colombia' connected with the drug trade. Have a good look at his picture<sup>16</sup>. What you see is an **actor** playing the role of drug boss for the intelligence agencies that he works for. It is just another drama for the cameras to let the Ecuadorian people believe that president Noboa is 'cracking down' on drug crime. He isn't. He is just facilitating it and paving the way for rampant fascism in Ecuador through fulfillment of the IMF loan terms. That is the simple truth. Noboa's father, who is a banana billionaire, probably uses some of the banana boats to transport cocaine into Europe and North America, the two biggest drugs markets in the world. And why not? Cocaine is insanely profitable so why not get a cut of it?

3. Noboa did another interview<sup>17</sup> in which he basically said that he is going to **extend** the state of emergency with another 30 days, to total it to 90. Even though he is constitutionally allowed to do this, the 'war on drugs' is fake and so he is using that as an excuse to neutralize opposition and pass unfavorable economic laws that will benefit the ultra rich international Jewish banking families. He also said he wants total control. Fascism has arrived in Ecuador, no doubt.
4. As predicted the constitutional court has approved<sup>18</sup> the most important questions for the upcoming referendum. As Noboa has more than 80% approval rate, the fearful Ecuadorian people will massively vote 'yes' to the questions, basically paving the way for Noboa to sign everything into law. It will give the military unprecedented powers to function as a police force on the streets, 'because drug gangs'. The usual excuse. Noboa also threatened<sup>19</sup> the opposition groups, primarily the indigenous communities, to not go on protests as that is 'illegal' during the state of emergency and also that if they do, that they would have to **face the military**. Welcome to fascist dictatorship Ecuador.
