

Why you are a slave. By consent.

I know it is a hard pill to swallow, but I want to be sincere. With all due respect to anyone. This is not about bashing anyone, but about being realistic of the state that most people are in. And that state is that they are being a **slave**.

In simple terms, a slave is an individual that gives away their time, energy and effort in a way that benefits somebody else, with a perception of giving that away **involuntarily**. A slave is somebody that perceives that things are taken away without their consent.

But the opposite is true: It is actually by **consent**, no matter how the individual **feels** about it. Examples of this is paying taxes, obeying rules that seem unjust or even going to jail. **Nobody** forces you to do any of those things. It is just **perceived** in the mind to be by force. But it isn't. It is **all** a **contract**.

When you **choose** to act on behalf of your persona, i.e. on behalf of your birth certificate or ID card, you **enter** into a contract with the agent of the system that you contract with. You will be **subject** to that system and you will **have to obey** the rules and conditions of that system and the conditions of the contract. When you enter into a contract you are **bound** by it. And to be bound by it means that you are subject to that contract, **until** it **ends**. It means that you are a slave to that contract until it ends.

The contract can end when the time period of the contract has ended, or when all conditions that have been set within the contract are satisfied or when you have **stopped** identifying with the **persona**.

Outside of the legal system, you can go to a farmer and enter into an agreement with that farmer. You work one day and for your work and time, the farmer gives you a box of food from the land. It is fair and it is just, because both parties have something to exchange. You exchange your energy and time and the farmer exchanges food from the land. It is called **consideration**. Both parties have something of value to exchange.

This does not work the same in the legal system. In the legal system you give away your energy and time and the system is **not** giving you **anything** in return. Or the system gives you something that is much **less** in value than what you put on the table. When you go to the bank and borrow money for a house, you sign off a **promise** to work for, let's say, 30 years to pay off that debt. So you bring 30 years of labor to the table.

The bank in turn, does **not** bring anything to the table. When you sign your promise on behalf of your persona, the bank goes ahead and **creates** that money **out of nothing** in that very same moment. They take your 30 years and give you just-created numbers on your account. In other words, there is **no consideration** in that transaction. The bank

does **not** take that money from the savings of others, rather it creates it out of nothing on the spot. It is **100% proven** that the balance sheet of the bank grows with **every loan** they accept. Their balance sheet **does not** grow with the increased productivity of the people. So you get nothing for your time and labor. You get digits on some computer.

That is the reason why you are a slave. You get nothing for your something. And you are a slave voluntarily. Why? Because you signed the contract of the loan. That's why. You consented. You consented to a bad deal. You consented to banking parasites. You will say, yeah but now I have money and I can spend it on a house. No, you have nothing. You **do not** own the house. The government does, through its intermediary, the bank.

What you have is a promise to work 30 years for something you **do not own**. You are only a caretaker of the house and you are allowed to live in it, but you do not own it. You miss one payment or you go out of line of the rules and they will take it away from you. That is also true for your children and anything you think is yours. You own nothing.

So what you will do is go out there and work and pay taxes and obey the rules for 30 years to finally pay off the house. Is it yours then? No, it is still of the government. Because you have to pay property taxes. So you don't really own it if you have to pay somebody else's money on something you think you own, do you? Think about it.

When something is not really yours and you have to work for something that is not really yours, you are a slave. **By consent**. Because you **signed** for it. You **agreed** to it.

Who voted for yet another crooked politician? Who got into student debt? Who signed a contract with an employer and consented to obey some bozo boss? Who registered their children? Who took out a loan for that new TV or car? Who filed a tax report and paid it? Who believed all the lies on TV and in newspapers? Who let the child services take away their children? Who signed up their children to a school to get indoctrinated? Who took that nice long vacation to Bali last year? Who bought all that crap food and got sick by it? Who lined up to get the next poison flu shot? Who agreed to show up in the court of 'law' and consent to some asshole in a black robe who was intimidating you? Who signed hundreds of contracts throughout their life for one thing or the other?

You did.

So stop being a victim and realize that everything you ever did in your life was **by consent**. You agreed to it. Every **single** last one of it. And it was all by using a **false persona**, your mask, your personal identification. When you use that, you enter into a contract and the system can basically do **anything** it likes with you. Why? Because, when using your persona, you **agree** to all of that. You consented. You submitted to it.

Everything you **do** is a **contract** with somebody else. But the system is unfair. You **always** get a bad deal and the short end of the stick. Not with the farmer.
